- a. All quotations must be submitted with specification forms included in this BID package. Webb County will not accept price schedules that are submitted on forms other than those furnished in this BID package.
- b. Webb County reserves the right to hold all BIDs for a period of thirty (30) days from the date of the public opening, without taking action thereon.

ANNUAL CONTRACT FOR ELECTRICAL SERVICES TO WEBB COUNTY

1.1 GENERAL SPECIFICATIONS:

The purpose of this proposal is to establish specifications and solicit bids to acquire the services of a licensed electrical contractor to provide labor, parts, and equipment to perform electrical services throughout WEBB County. This applies to projects less than \$20,000. The County reserves the right to bid separately any job deemed to be in its best interest. The quantity and nature of work will vary throughout the term of this contract. Detailed Specifications are as follows:

1.2 CONTRACT SPECIFICATIONS:

1.2.1 The contract period will be for a period on one (1) year with renewal options for four (4) additional one (1) year terms, if all parties agree. Contract prices are to remain fixed for the duration of the contract.

1.2.2 The terms and conditions of this contract will allow for the Contractor to Subcontract work should the need arise, however, all subcontractors must first be approved by appropriate representative of Webb County Utilities.

1.2.3 Contractors' licensing for himself and all of his employees that will be performing on the resulting contract must submit license with bid submittal. Contractor is to include a listing of all electrical employees with bid submission.

1.2.4 The Contractor will be required to do emergency services at times other than normal working hours. He shall be in a position to respond on a twenty-four hour basis, seven (7) days a week for such emergency work. Response time will be within four (4) hours for the emergency services.

1.2.5 All "Non Emergency Work" is to be scheduled within 48 hours of service call. This is to be arranged between Contractor and appropriate representative of Webb County Utilities.

1.2.6 Electrical Contractor will troubleshoot and/or diagnose electrical problems and recommend emergency or routine repair programs as requested.

1.2.7 All work must be done in accordance with the national code, current edition, and all state and local codes.

1.2.8 Contractor shall clean up and remove all debris and rubbish resulting from his work. Work site is to be left in a clean and satisfactory order.

1.2.9 Electrical Contractor will ascertain from each Webb County Utilities Representative the availability and cost of necessary parts. County personnel will procure parts as necessary or will designate for the Contractor to supply parts.

1.2.10 Replacement parts furnished must be of the same manufacturer or an equal product.

1.2.11 Contractor is not required to "own" special equipment such as boom trucks, bucket trucks, backhoes, etc. However, Contractor must have quick access to such equipment when needed to accomplish job. All "other equipment" is to be included in Contractors' bid for hourly labor rates. "Other Equipment" does not include the above listed items. Contractor will immediately notify County Representative, if a "Specialty" item not covered under this contract (such as a crane or jackhammer) is required to perform a service request.

1.2.12 Completion time of services shall be negotiated for each job by the Contractor and Webb County Utilities Representative to determine a reasonable time for service completion.

1.2.13 Pricing will be based on labor rates and material costs. It is anticipated that the vast majority of jobs can be handled with a two (2) person crew, consisting of one electrician and a helper. The County reserves the right to approve the number of employees prior to work. A rate for additional helpers will be indicated in the event that additional workers are needed. Those labor rates will include all miscellaneous tools and/or other small equipment required. The labor rates will be quoted at a regular working hourly rate or by weekend/holiday hourly rate. Webb County Utilities will honor a minimum 1 (one) hour billing for any service required. For material costs, a percent mark-up from vendor's procurement costs should be indicated. Labor quoted shall include all labor cost, insurance, overhead, profit, travel time and mileage. Copies of invoices or other appropriate documentation will be supplied with each job to support material costs.

1.2.14 Webb County Utilities is not responsible for payment of "Travel Time". Hourly rates shall be billed as follows:

EMERGENCY CALLS- Hourly rate will begin at time of contractor's mobilization.

NON-EMERGENCY CALLS- Hourly rate to begin when Contractor arrives at job site

1.2.15 It is expected that this bid will be awarded to a primary and secondary Contractor based on price and other considerations. The County reserves the right to utilize the secondary Contractor in emergency situations or when the primary supplier has more work than he can reasonably handle.

1.2.16 Contractor will be responsible for servicing several Webb County Utilities Departments at various locations. Included but not limited to the following locations:

Rio Bravo Water Treatment Plant
Rio Bravo Wastewater Treatment Plant
Webb County Utilities Main Office
Colorado Acres Reverse Osmosis Water Treatment Plant
Rio Bravo and El Cenizo Elevated Water Storage Facilities
Rio Bravo and El Cenizo Wastewater Lift Station Facilities

1.3 QUALIFICATIONS:

1.3.1 Contractor shall be licensed by the State of Texas and have a license to work and operate as a business in Webb County.

1.3.2 Contractor must submit a breakdown of shop personnel indicating classification (i.e. journeyman, apprentice, etc.) and number in each category. Appropriate documentation, certifications, etc., are to be submitted with bid/proposal package.

1.3.3 The Contractor shall follow all guidelines, rules, and regulations as set forth in the most recent National Electrical Codes. Contractor will be subject to any future State / Webb County Electrical Codes.

1.3.4 Contractors must be qualified and familiar with all type electrical systems inclusive of water and wastewater systems and must have demonstrated a past history of responsiveness, technical enterprise, and professionalism.

1.4 WARRANTY REQUIREMENT:

1.4.1 Standard manufacturer's warranties shall apply to all parts. All work shall carry a one (1) year warranty. Contractor will guarantee all workmanship for a period of one (1) after completion of work.

1.4.2 Contractor must provide a written warranty satisfactory to the County covering all parts and labor.

1.4.3 All parts and work under this contract must conform to manufacturer's specifications when applicable.

Purchase Orders: Vendor must have a purchase order before making a delivery. Purchase Orders will be issued for each department authorized to place an order against the annual contract. The Purchase Order will list the individual items and or services along with the price.

Invoices: all Original invoices must include invoice number, invoice date, purchase order #, and corresponding department. All items must show a clear description of items purchased, and quantities ordered.

Unit Price: Unit prices shall be shown and where there is an error in extended price, the unit price, shall govern.

Taxes: Vendor shall not include Federal Taxes or State of Texas Limited Sales Excise and use taxes in bid prices. The County of Webb is exempt from payment of such taxes. A signed exemption certificate will be available upon request.

Substitutes: Item substitutes must be authorized by ordering department, and must be billed at contracted price. Substitute items must be of equal or better grade and/or value than the item being substituted.

Capacity: Vendor must prove beyond any doubt to the County that they are duly qualified, and capable to fulfill and abide by the specifications herein listed.

Delivery:

Delivery to be made within 24 hours from request

Contract:

This contract will be awarded to the lowest, responsible bidders. The county reserves the right to award the contract to the bidders with the lowest price and/or overall Best Value. The county may award contracts to various bidders depending on geographic location within Webb County or other criteria. A signed award letter is required for a valid contract.

Award of Bid:

Bidder must bid on all items on each section, quantities listed are best estimates actual quantities to be purchased may exceed or may be lower than quantities specified. If bidder is unable to bid on a particular item, please provide a written explanation.

Availability of Funds for Next Fiscal Year:

Funds are not presently available for performance under this contract beyond September 30, 2015. The County's obligation for performance of this contract beyond this date is contingent upon the availability of appropriated funds from which payment for the contract purposes can be made. No legal liability on the part of the County for payment of any money for performance under this contract beyond September 30, 2015 shall arise unless and until funds are made available to the Purchasing Agent for such performance and notice of such availability, to be confirmed in writing by the Purchasing Agent, is given to the contractor.

Payment of Bills:

It is hereby requested by the Webb County Commissioner's Court that all vendors submit requests for payment within 90 days after the providing of goods and/ or services to the County. This practice will allow your payment request to be processed efficiently and will expedite payment to you.

Delinquent Taxes:

All vendors seeking to do business with Webb County must owe no delinquent taxes to the County. Attestation of owing no delinquent taxes will be required. If a vendor owes taxes to Webb County, those taxes should be paid before submitting a bid/proposal.

Legibility: Proposals must be legible and of a quality that can be reproduced.

FOB Destination:

All of the items listed are to be Free On Board to final destination (FOB Destination) with all transportation charges if applicable to be included in the price, the title and risk of loss of goods shall not pass to the County until receipt and acceptance takes place at the FOB point.

Estimated Quantities & Minimum Orders:

The estimated quantity to be purchased may be more or less. The County may purchase any reasonable amount greater than the estimate for the same unit price. The County is not obligated to purchase any minimum amount, and will require delivery regardless of the amounts ordered. The County will order on an as needed basis.

Statements:

No oral statement of any person shall modify or otherwise change, or affect the terms conditions, plans and/or specifications stated in the various proposal packages and/or proposal instructions/ requirements.

Pricing: Pricing provided in the bid by the vendor must remain constant for the duration of the contract, and all prices must be rounded to the nearest cent. All charges, surcharges, fees, and

all costs associated with shipping must be reflected in the price. Webb County will not pay charges that are not stipulated in our contracts.

Other Fees, Charges, Surcharges: Webb County does not pay for, Overtime charges, Fuel Charges, Rental fee, Travel Fees and or surcharges for entities located out of town, or any other fees that are not stipulated in the contract.

Quote Fees: If a vendor is providing an estimate for work not under contract, the vendor must identify the estimate fee prior to diagnosing. A purchase order will be necessary if a fee will be applied to quotes and or estimates.

Termination: The County of Webb may terminate their participation in this contract upon thirty (30) Days written notice.

Ethics: The proposer shall not accept or offer gifts or anything of value nor enter into any business arrangement with any employee, of the Webb County Purchasing Department.

Proprietary Information:

All materials submitted to the County become public property and are subject to the Texas Open Records Act upon receipt. If a Proposer does not desire proprietary information in the proposal to be disclosed, each page must be identified and marked proprietary at time of submittal. The County will, to the extent allowed by law, endeavor to protect such information from disclosure. The final decision as to what information must be disclosed, however, lies with the Texas Attorney General. Failure to identify proprietary information will result in all unmarked sections being deemed non-proprietary and available upon public request.

Furnished Forms: All bids should be submitted on furnished forms. Bids submitted on forms other than those provided by Webb County will not be considered.

Open Market: If awarded vendor cannot provide the items under this contract, or abide by the terms & conditions of this contract, The County reserves the right to purchase items from the open market, and or terminate the contract upon a 30 day written notice to the vendor.

Specification Clarification: If any person contemplating submitting a proposal for this contract is in doubt as to the true meaning of the specifications, or other proposal documents or any part thereof, they may submit to the Purchasing Agent on or before 5 days prior to the closing date of the BID/RFP/RFQ a request for clarification. Changes and or clarifications to the specifications will be done in the form of an addendum. The addendum will be posted on the Webb County website (www.webbcountytx.gov), and emailed to the vendors that are on the Webb County vendor list. Questions may also be submitted 5 days prior to the closing date of the BID/RFP/RFQ, and will be answered, and posted on the Webb County website.

Liability Insurance: A copy of your liability insurance must be included with your package.
